1. How to Apply

- 1.1. Fill in the application form, selecting relevant training programme and venue for applicant.
- 1.2. Include two 4" x 6" (10cm x 15cm) full length photographs (standard size) of applicant in practice clothes with student name on reverse side.
 - 1x Facing side in profile to the camera with feet in parallel 1st
 - 1x Tendu à la seconde à terre en face with arms in 2nd
- 1.3. Post the application form with payment (Please ensure applicant's name is recorded on reverse of any cheque) to:

- 1.4. Please note that applications will not be processed if illegible or incomplete and that faxed or emailed forms cannot be accepted.

2. Conditions of Enrolment

- 2.1. The Australian Ballet School reserves the right to make amendments to its schedule without prior notice either before or during a session or to cancel a session.
- 2.2. The Australian Ballet School reserves the right to merge published age groups and schedule classes as required.
- 2.3. The Australian Ballet School reserves the right to refuse any enrolment as permitted by law or to request a participant to leave a session if he/she is disruptive, late due to unpaid fees.
- 2.4. The Australian Ballet School provides supervision of participants during session hours only.
- 2.5. The Australian Ballet School and all venues used by it are non-smoking.
- 2.6. Waiting room facilities and studio seating are not available at venues.
- 2.7. In booking into a session with The Australian Ballet School, participants (or their parents/guardians) acknowledge that activities are physical and may involve the risk of accidents occurring.
- 2.8. All material recorded during classes is the copyright of The Australian Ballet School.
- 2.9. Participants may not make recordings (audio, videos or photos) of any activities at The Australian Ballet School or other session venues.
- 2.10. Recordings of class work are not provided to participants.
- 2.11. Parents must advise The Australian Ballet School in advance of the session if their child has health problems and/or requires medication while attending a session. The Australian Ballet School staff take care of applicants during their classes, but cannot be responsible for the administration of medication or ensuring suitable health precautions are in place to suit all participants.

3. Confirmation of Audition

- 3.1. All applicants will receive a confirmation letter providing details of the venue and audition class schedule approximately two weeks prior to audition via email.
- 3.2. If you have not received any communication from the School one week prior to the scheduled audition date to confirm your audition time, it is the applicant's responsibility to contact The Australian Ballet School.

4. Refund Policy

- 4.1. The Australian Ballet School is unable to offer refunds unless the audition is cancelled by the School.

5. General Information

- 5.1. Applicants must enrol and pay in advance. Bookings cannot be made without payment.
- 5.2. Applicants for the Interstate Training Programme/After School Programme must be at least 8 years old as at 30 June 2017 to audition for 2018 intake.
- 5.3. Audition applications should be received two weeks prior to the audition date allowing for processing and confirmation details to be forwarded to the applicant.

- 5.4. No further feedback or discussion will be entered following an audition.

- 5.5. Preferred dress for audition:

Girls: Leotard, pink ballet tights, ballet shoes

Boys: Singlet top/t-shirt and tights or full length tights/unitard with socks and ballet flats

- 5.6. Auditions are generally conducted during the day.
- 5.7. The Australian Ballet School collects and uses applicant information in accordance with the relevant privacy legislation.

- 5.8. The School may take and use photographs and videos of programme participants for promotional and archival purposes only. If you do not wish to have your child's photo used by the School, please inform your child so they can advise a staff member at registration, plus the photographer and can remove themselves from any photo/video footage as it is being taken. All material recorded during any programme is the copyright of the School.
